### Seasonal Policies:

\*All campground policies pertain to everyone on property.

\*You must register your camping family by signing our liability waiver. All visitors and camping guests must check in and pay their appropriate visitor/camping fee.

\* Whiskey Creek Trail Permits are included in your seasonal camping rates. However, if you have any guests, their trail vehicles must obtain a **\$5.00** permit per vehicle per stay.

\*Site and camper "upkeep" is your responsibility. Your site and camper should be clean and clutter free. A community lawn mower is available and camper cleaning can be requested and scheduled in the camp store.

\*Any changes to your site such as storage units, decks and anything larger than your camper must be approved by Chad and Danielle.

\*Buddy site occupants must remain on assigned site for the duration of the season. Any site swapping or relocating must be approved by Chad and Danielle.

\*Your electric meter will be read the 1<sup>st</sup> of each month and will be calculated and invoiced to your email address on file. You may pay your electric bill online or in the camp store within 14 days. We appreciate timely payments.

**Current Seasonals:** To remain on your current site a **\$350 non-refundable deposit** must be received by October 31, 2019. An invoice will be sent to your email address on file. The site will be considered available on November 1, 2019 if a deposit is not received. The remaining balance of **\$1850** is due in full by April 1, 2020. The site will be considered open for the season and we will begin booking it if the payment is not received in full by April 1, 2020, no exceptions.

**Potential Seasonals:** Available sites will not be determined until April 1, 2020. You may place a **\$350** deposit down to request a site, by filing out the form below. If your site request is unavailable your deposit will be considered for any available site. Once a site is assigned to you, your **deposit is non-refundable**. The remaining balance of **\$1850** is due in full by April 1, 2020. The site will be considered open for the season and we will begin booking it if the payment is not received in full by April 1, 2020, no exceptions.

\*Camping season is May 1 through October 31; however, you are welcome to set up your site beginning April 1, if your balance is paid in full. Likewise, if your deposit, winter storage fee and electric bills are paid in full by October 31, you are welcome to winter camp.

\*Keep in mind the campground and all of its amenities, such as running water, will not be officially open until May 1 and will officially close on October 31. Roads are not snow plowed.
